Any member of the Lawrence County Genealogical Society may become a member of THE FIRST FAMILIES OF LAWRENCE COUNTY, OHIO, if they can document that they are a direct descendant of an individual who settled in the area now known as LAWRENCE COUNTY, OHIO no later than Dec. 31, 1840. The completed application accompanied by the required proofs and a NON-REFUNDABLE (One time only) \$15.00 application fee may be filed at any time. Applicants who file before the first Tuesday in September, will usually be approved in time to be honored at the annual banquet in November. This application must be examined and approved by the FIRST FAMILIES OF LAWRENCE COUNTY, OHIO, committee, who may ask for additional information. Please include a five-generation chart that includes the ancestors whose residence you are proving.
